

Polsinelli Climbs in PitchBook's 2025 Global League Tables

(March 3, 2026) Polsinelli has again earned broad national and global recognition in **PitchBook's 2025 Global League Tables**, achieving rankings across 49 categories and demonstrating continued momentum across its transactional platform. The firm recorded 38 increases in ranking and secured nine new category recognitions.

Polsinelli was again ranked among the most active law firms in the United States across all three deal categories — M&A, Private Equity and Venture Capital — and earned multiple global rankings for representing companies.
