In addition to his patent litigation practice, Colby has an extensive copyright, trademark, and unfair competition practice. Colby has represented a variety of clients with respect to claims of copyright infringement including matters involving copyright misuse and DMCA safe harbors. Colby has both prosecuted and defended cases in venues across the country involving the Lanham Act, including claims of trademark infringement under Section 1114, false designation of origin and misleading description under Section 1125, as well as unfair competition and false advertising likelihood of confusion. These litigations have involved the world's largest manufacturer of computer software and one of the largest manufacturers of multimedia, creativity, and rich Internet application software. Colby regularly defends cases involving California's complex network of unfair competition laws including 17200 and 17500 actions under the Business and Professions Code and the California Consumer Legal Remedies Act.

Colby also maintains a California state trade secret misappropriation practice and regularly counsels clients under the federal Defend Trade Secrets Act.
