# **Products Liability and Consumer Class Action Litigation Matters**

- Defense liaison counsel for generics pharmaceutical defendants in the *In re Zantac* multidistrict litigation (MDL), MDL 2924, in the U.S. District Court for the Southern District of Florida and national counsel for pharmaceutical company in personal injury product liability and consumer and third party payer putative class action litigation related to ranitidine (Zantac) drug products and alleged exposure to N-Nitrosodimethylamine (NDMA), over cancer risk claims; won dismissal of all cases on all causes of action on behalf of generics defendants in the MDL, which involves over 150,000 plaintiff claimants; also serving as liaison counsel for generics manufacturers in coordinated state court actions, including Pennsylvania and California, and in the U.S. Court of Appeals for the Eleventh Circuit.
